2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the proximal femoral nail antirotation. The topic is within the scope of the WJO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an interesting case, and the manuscript is well written. However, there are some issues should be addressed. Union rate in both groups not mentioned. The author should provide two examples and should include figures.</p>	[Y]

Which complications have been evaluated? The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. A total of 29 references are cited, including 2 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (3) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
