2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the narrow pelvic inlet plane area and obesity as risk factors for anastomotic leakage after intersphincteric resection. The topic is within the scope of the WJGS. (1) Classification: Grade C, Grade C, and Grade D; (2) Summary of the Peer-Review Report: The authors investigated the risk factors for</p>	[Y]

anastomotic leakage after intersphincteric resection based on clinicopathological variables and in particular on the role of pelvimetry, which is interesting. However, some more details about the techniques/procedure performed should be added. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 20 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade B. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the STROBE Statement, and the Institutional Review Board Approval Form. Written informed consent was waived. The Conflict-of-Interest Disclosure Form is not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of

	<p>the references. Please revise throughout; and (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. The authors need to complete the Conflict-of-Interest Disclosure Form. The authors have written the “author contribution” section. The authors should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
