2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a review of the multifunctional role of microRNA in mesenchymal stem cell derived exosomes in the treatment of diseases. The topic is within the scope of the WJSC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: This is an interesting review that focused on the role of miRNA in MSC derived exosomes and the methods commonly used to study miRNA in</p>	[Y]

exosomes. The clinical applications of miRNAs from MSC derived exosomes are also discussed. In general, the manuscript is well written; please revise the English language and check throughout the text for spelling errors. Reviewer suggest to include a brief discussion on the importance of regulatory mechanisms that could represent a promising target to develop RNA-based therapeutics against tumors. In this review, the term “mesenchymal stem cell derived exosomes” were not unified. The authors use only one abbreviation; and (3) Format: There are 3 tables and 2 figures. A total of 178 references are cited, including 65 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by English Specialist was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Major Scientific and Technological Special Project for “Significant New Drugs Development” of China, National Key RD Program of China, and National Natural Science Foundation of China. The topic has not previously been published in the WJSC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding
