The topic is within the scope of the WJSC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors investigated the novel insights for improving the therapeutic safety and efficiency of mesenchymal stromal cells.</p>	[Y]

However, some grammar, spelling, and punctuation mistakes need to be revised. The questions raised by the reviewer should be answered; and (3) Format: There are no tables and figures. A total of 118 references are cited, including 83 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors are the native English speakers. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s) 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
