provided correctly, please provide language certificate by language editing company. 3 Academic norms and rules: The conflict-of-interest disclosure form and Copyright License Agreement were provided. No academic misconduct was found in the Bing search and the similar index is 35% in the CrossCheck search, the repeated sentences should be rephrased. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has published 2 articles in BPG. 5 Issues raised: (1) Please provide the author contributions. (2) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. (3) Please add "article highlight" section. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.

**Editorial Office Director:** I have checked the comments written by the science editor. The "article highlight" section is not required. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences.

**Company Editor-in-Chief:** I have reviewed the Peer-Review Report and the full text of the manuscript, of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revision. Before final acceptance, the authors need to make sure all text that has been legitimately cited.
