POCUS. However, for the ultrasonography, the authors should give more image examples. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 41 references are cited, including 35 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. The authors are the native English speakers. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJR. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required by Reviewer 05382886. 7 Recommendation: Conditional acceptance.
