(1) Classification: Grade B, Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: It is a well written case report of abdominal aortic thrombosis as initial presentation of COVID-19 infection in a 60-year-old man. patient had no any other symptom indicative of an infection and more specifically COVID-19 disease. Please discuss alternative treatments to Tocilizumab or if more doses of this medicine could be administered in a patient with extensive located thrombosis. The questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 8 references are cited, including 8 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade A and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and the CARE checklist form. The authors need to provide original informed consent. The authors need to confirm the author list (the authors list of the manuscript is not consistent with the author list of the F6publishing system). No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCID. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list

	<p>and list all authors of the references. Please revise throughout; (4) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (5) I found the "abstract" did not meet our requirements.
