Grade C and Grade D; (2) Summary of the Peer-Review Report: Well written manuscript. This study is clearly presented. This manuscript gives additional new knowledge to the existing literature. However, there are some issues should be addressed. While the presented experimental data clearly support the reached conclusion, the manuscript suffers from the diffused discussion, which requires judicious shortening. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 35 references are cited, including 3 references published in the last 3 years. There are 9 self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. A language editing certificate issued by Honyaku was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No animals are involved in the study. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Scientific Research from the Ministry of Education, Culture, Sports, Science, and Technology; and National Fund for Innovation and Development of Science and Technology (FONDOCYT) from the Ministry of Higher Education Science and Technology (MESCyT) of the Dominican Republic. The topic has not previously been published in the WJG. The corresponding author has published 1
