However, author have given several limitations of proposed study; and (3) Format: There are 4 tables and 2 figures. A total of 31 references are cited, including 17 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Key R&D Program of China; the National Science Foundation of China; the Major Research Plan of the National Natural Science Foundation of China; and the Hubei Science and Technology Support Project. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
