and facilitate precision therapy for patients with GC. The number of participants in the study is large enough. However, there are some issues should be addressed. Please shorten the introduction. Please be consistent with the second paragraph of the introduction. Please contextualize recently study results with those already available, in the discussion. Please check some of the references. The reviewer would suggest authors add a flow chart to show the process of case inclusion and exclusion more clearly. The questions raised by the reviewers should be answered; and (3) Format: There 6 figures. A total of 37 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form and informed consent are not required. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was performed with 7 financial supports. The topic has not previously been published in the WJG. The corresponding author has published 7 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the
