are some issues should be addressed. There are still shortcomings in the discussion, and the discussion is not sufficient. The questions raised by the reviewers should be answered; and (3) Format: There are 9 figures. A total of 36 references are cited, including 3 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No animals are involved in the study. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by The Daniel M. Soref Charitable Trust, Center for Imaging Research, Medical College of Wisconsin, USA. The topic has not previously been published in the WJR. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please provide the original figure documents.
