2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the TNC/mir-155-5p participate in DKD inflammation and fibrosis. The topic is within the scope of the WJD. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Authors investigate the role of tenascin-C (TNC) in diabetic kidney disease (DKD). The main finding of this study is that TNC, which is</p>	[Y]

associated to DKD, TLR4 and miR155-5p are involved in a molecular loop that induce the production of extracellular matrix proteins and may contribute to DKD. These results add information on the pathobiology of DKD and may offer novel therapeutic targets for DKD treatment. Nevertheless, providing additional evidences that support authors' conclusions are advisable and would add value to the manuscript. Statistics used in the Table 1 should be revised, there is not possible to use parametric statistics, SDs are too much wide. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 11 figures. A total of 57 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2
Language evaluation: Classification: Grade B and Grade B. 3
Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form, and the ARRIVE Guidelines. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 7%. Please rephrase these repeated sentences. 4
Supplementary comments: This is an unsolicited manuscript. The study was performed with 3 financial supports. The topic has not previously been published in the WJD. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found

no “Author contribution” section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (6) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (7) please don’t include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters.
