(1) Classification: Grade B, Grade D, and Grade C; (2) Summary of the Peer-Review Report: The authors reported association between time-in-range by CGM with autonomic dysfunctions in patients with T2D. This is a very comprehensive and well written paper. The whole structure and logicity of this</p>	[Y]

paper are quite good. However, some syntax/s spelling errors need to be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 30 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form is not qualified. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 7 grants. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
