The topic is within the scope of the WJD. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The work is novel and important in the current time. Reviewer recommend re-writing the</p>	[Y]

introduction portion of the manuscript; and (3) Format: There are 5 tables and 6 figures. A total of 41 references are cited, including 22 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B. A language editing certificate issued by RICEL was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 6%. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Ministry of Education and Science of Russia. The topic has not previously been published in the WJD. The corresponding author has 1 published articles in the BPG.
