(1) Classification: Grade D; (2) Summary of the Peer-Review Report: The authors presented very nice case and beautiful images of IPNB demonstrated with SpyGlass. However,</p>	[Y]

the authors did not provide detail of patient's physical examination as mentioned in CARE checklist. The reference(s) to support the higher diagnostic efficacy of POC visual impression and the cholangioscopic images and cholangiogram images should be added in it. The questions raised by the reviewer should be answered; and (3) Format: There is 1 figure. A total of 4 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and the Written informed consent. The Copyright License Agreement is not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGE. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS",

	<p>“TREATMENT”, and “OUTCOME AND FOLLOW-UP” sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.
