The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript reported pathology characteristics and analyzed risk factors for the incidence of the disease, unsuccessful operation and postoperative complications in patients with colorectal polyps undergoing</p>	[Y]

endoscopic mucosal resection. The trial was well thought-out and adequately carried out with equipment and protocols described in detail. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables. A total of 21 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
