The topic is within the scope of the WJGE. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: The topic is of timely relevance, and the paper is well written and interesting. However, more information on</p>	[Y]

comorbidities and history of the individual patients should be included as to better understand the indication for POEM. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 35 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and the Institutional Review Board Approval Form. Written informed consent was waived. The STROBE Statement lacks of the page number. The Copyright License Agreement lacks of the signature in handwritten. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGE. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights"
