2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the endoscopic radial incision and cutting technique for treatment-naïve stricture of colorectal anastomosis. The topic is within the scope of the WJGS. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The case presentations were good overall. The authors also reviewed various treatment options for colorectal anastomotic stenosis in detail, both surgical and</p>	[Y]

endoscopic. However, the authors could not reach the conclusion of this article from only these two cases. The questions raised by the reviewer should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 21 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the CARE Checklist-2016, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJCC. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
