The topic is within the scope of the WJCCM. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors summarized the available literature evaluating vasopressin versus non-vasopressin alternatives on the clinical and patient-centered outcomes of vasoplegic shock in adult Intensive Care Unit patients. This is a very interesting study. The study was well planned,</p>	[Y]

organized and written. However, some suggestions may be useful for improving this study. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 9 figures. A total of 39 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The PRISMA 2009 Checklist lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCCM. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
