The topic is within the scope of the WJG. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: This study aims to study the utility of CEUS in</p>	[Y]

differentiating CHC from HCC or ICC which is clinically very important. One potential bias for this study is that everyone had histologically confirmed CHC, ICC, and HCC from liver resection. Another potential issue of this study is sample size which resulted in low AUC noted in discussion section and Table 5. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 4 figures. A total of 30 references are cited, including 12 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application
