The topic is within the scope of the WJH. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: It is a very interesting and novel work, because through the analysis of these different types of data it determines the key deregulated genes and pathways in HCC. The methodology is</p>	[ Y ]

described in detail and the analysis is well-conducted, covering 85 studies and 3,355 HCC patient sample profiles. Discussion would be improved if authors discuss other articles describing this type of integrative analysis of big 'omics' data from other tumor types, for instance, breast cancer, ovarian cancer. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 25 references are cited, including 3 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the signed Conflict-of-Interest Disclosure Form. The authors need to provide the Copyright License Agreement signed by all author. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 7%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Ontario Research Fund; and Canadian Institutes for Health Research Fellowship for Health Professionals. The topic has not previously been published in the WJH. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I

found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
