infected with *Leishmania panamensis*. The diagnosis and treatment were described in detail. This paper was helpful for readers to understand the importance of leishmaniasis, especially in endemic areas. However, there are some issues should be addressed. The discussion section should be modified and compare the case with similar cases and discuss about the details. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 24 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the CARE checklist form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCID. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation:
