The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: This is a well-designed and well-executed study examining bile acid composition in IBS-D patients in addition to assessing potential correlations with changes</p>	[Y]

in microbial profiles. However, there are some issues should be addressed. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 57 references are cited, including 14 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, Written informed consent, and the STROBE checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Key Technology Support Program during “12th Five-Year Plan” Period of China; and a research projects of China-Japan Friendship Hospital. The topic has not previously been published in the WJG. The corresponding author has not published 4 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure
