Grade C; (2) Summary of the Peer-Review Report: This is an interesting article. However, there are some issues should be addressed. The authors need to improve the language and expand the discussion. It is better to add more recent references. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. A total of 27 references are cited, including 8 references published in the last 3 years. There are 9 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and STROBE Statement. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Council for Scientific and Technological Development (CNPq) and Foundation for Research Support of the State of Rio de Janeiro (Faperj). The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the
