NASH. The topic is within the scope of the WJG. (1) Classification: Grade A, Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors evaluated the accuracy of mpMRI on NASH and NAFL diagnosis in the prospective cohort and proved a fairly good performance for the non-invasive diagnosis. The study is interesting and well written. However, there are some issues should be addressed. It would be better to verify the results in different cohorts. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 3 figures. A total of 50 references are cited, including 16 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, informed consent, and Clinical Trial Registration Statement. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the CONSORT checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the

	<p>editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
