The topic is within the scope of the WJCCM. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors should talk about a potential benefit of the IABP and make it appear in the conclusion. reviewer should be answered; and (3) Format: There are 3 tables. A total of 33 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 8% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCCM. 5 Issues raised: (1) The short title should be provided in no more than 8 words; (2) The authors' information should be added in the first page; (3) The "Author Contributions" section is missing. Please provide the author contributions; (4) The reference's number should be put in the square bracket, then make them be superscript; (5) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (6) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
