2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1 Scientific quality:</b> The manuscript describes a basic study of the osseointegration of porous titanium and tantalum implants in ovariectomized rabbits. The topic is within the scope of the WJO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The aim of this paper is to examine the strength of bone-implant osseointegration of three porous titanium</p>	[Y]

and one porous tantalum materials in normal and osteoporotic bone in rabbits. The paper is well written, the study is well described. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 27 references are cited, including 10 references published in the last 3 years. There is 1 self-citation (Ref. 9). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Animal Care and Use Committee Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; (4) If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly

indicating the reference source and copyrights. For example, “Figure 1 Histopathological examination by hematoxylin-eosin staining (200 ×).
