The topic is within the scope of the WJCC. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors reported a review that can be useful for clinicians dealing with COVID-19 patients. It is well written. COVID-19 patients with liver disease should be added in the content. Some clarification, edits and additions are needed. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 69 references are cited, including 49 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Chinese National Major Science and Technology. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The cited references should be superscript in the text; and (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
