2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1 Scientific quality:</b> The manuscript describes a basic study of the ITF alleviates gastric mucosal damage. The topic is within the scope of the WJG. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: The manuscript describes protective effects of intestinal trefoil factor on stress induced-gastric pathological changes. Although experiments were designed and performed well and the manuscript was written</p>	[Y]

relatively in a straightforward manner, there are minor points to be considered. The authors should discuss the potential clinical advantages of ITF over conventional anti-ulcer agents such as PPIs and H2 receptor antagonists having a long clinical history and relatively validated safety clinical profiles. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 37 references are cited, including 17 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, Institutional Review Board Approval Form, Institutional Animal Care and Use Committee Approval Form, and The ARRIVE Guidelines. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 20%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited/invited manuscript. The study was performed with 7 financial supports. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant

application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (5) please don't include any \*, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
