The topic is within the scope of the WJG. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: This is a comparative study of ME-OE v/s</p>	[Y]

ME-AAC for GIM. The authors concluded that ME-OE is more efficacious for endoscopic evaluation of GIM a precancerous lesion. However, some questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 4 figures. A total of 23 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Clinical Trial Registration Statement, the CONSORT 2010 Statement, the Institutional Review Board Approval Form, and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
