experts in the field that summarize the state-of-the art on the use of PRP, BMA and BMAC in musculoskeletal disorders. Although this is a review, the author should also provide the strategy of include studies. Although given the scientific evidence, cannot reach to a conclusive evidence in favour of a specific treatment reflecting the limit of the currently available literature. The questions raised by the reviewers should be answered; and (3) Format: There are no tables or figures. A total of 80 references are cited, including 27 references published in the last 3 years. There are 7 self-citations. 2 Language evaluation: Classification: Grade A and Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJSC. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) the authors need to add some tables or figures; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the
