succeed to present their data in a clear way adding information to the existing literature. However, there are some issues should be addressed. The contents of introduction should be concise focusing on the background and aims. The clinical relevance of Figure 5 showing lipids in terms of cancer is unclear. Is the figure truly necessary? If necessary, please add some explanations. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 5 figures. A total of 40 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Charlesworth was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Health Development Planning Commission Science Foundation of Jiangxi Province; and Health Development Planning Commission Science TCM Foundation of Jiangxi Province. The topic has not previously been published in the WJD. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found no "Author contribution"
