The topic is within the scope of the WJD. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an informative paper that is based on care planning and implementation of a diabetes control protocol. The review article appears to be relevant to diabetes care and is useful for providing</p>	[Y]

general guidance to both practitioners and patients. It is unclear if the paper has adequately addressed the limitations of the strategy. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 5 figures. A total of 18 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors need to provide Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJD. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited
