The topic is within the scope of the WJV. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is an interesting study, and the manuscript is well written. be addressed. The authors should include a table gathering the main findings from literature about all of the clinical fields of application of Thymosin. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 46 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJV. The corresponding author has not published articles in the BPG. 5 Issues raised: I found no "Author contribution" section. Please provide the author contributions. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
