The topic is within the scope of the WJC. (1) Classification: Grade D, Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors investigate the impact of the number of trabeculated segments and the trabeculation ratio on regional and global left ventricular functions.</p>	[Y]
