The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an interesting review, and the manuscript is well written. However, there are some issues should be addressed. The reviewer</p>	[Y]

suggests the authors update risk classification definitions by referring to the latest guidelines. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 25 references are cited, including 20 references published in the 2020. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; and Nn10 Program of Harbin Medical University Cancer Hospital and Scientific Research Project of Heilongjiang Health and Family Planning Commission. The topic has not previously been published in the WJCC. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
