2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the impact of different stereoisomers of inositol on insulin sensitivity of GDM patients. The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: In this study, the authors discussed the impact of different stereoisomers of inositol on insulin sensitivity of gestational diabetes mellitus patients. The design of this study is very well, and the results are interesting. The questions</p>	[Y]

raised by the reviewers should be answered; and (3) Format: There are 6 tables and 2 figures. A total of 20 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (2) Please remove the figures as the reviewers' suggestion. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
