2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the evaluation of prognostic factors and clinicopathological patterns of recurrence after curative surgery for colorectal cancer. The topic is within the scope of the WJGS. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is a very important paper that evaluates a crucially important clinical question - what</p>	[Y]

are the factors associated with recurrence of colorectal cancer? By understanding these factors, clinicians would be able to better predict patients at risk for recurrence and allocate resources and cost/benefit considerations for these patients. However, minor grammar errors should be corrected; and (3) Format: There are 7 tables and 2 figures. A total of 35 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and The ARRIVE Guidelines. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The separated tables should be combined in one table; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
