The topic is within the scope of the WJSC. (1) Classification: Grade C and Grade A; (2) Summary of the Peer-Review Report: The manuscript is interesting and well written. This is a comprehensive and well-constructed review. However, corrections and modifications to the manuscript</p> | [Y] |

are recommended, some statements in the content of the manuscript need to be corrected, and the citation of references should also be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 1 table and 3 figures. A total of 119 references are cited, including 32 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJSC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
