Summary of the Peer-Review Report: The authors analyzed the effect of antiviral therapy on liver carcinogenesis in chronic liver disease patients related to hepatitis B virus, and concluded that early introduction of antiviral therapy should be cautious, because of lack of its decreasing effect on liver carcinogenesis in chronic hepatitis patients. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 50 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study.
