The topic is within the scope of the WJGO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an important study on cell-cell fusion and tumor initiating cells. mutation introduction and cell-cell fusion may be discussed more in detail. In addition, there are some things that need to be explained. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 143 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, Hubei Province Natural Science Foundation of China, Foundation of Health and Family Planning Commission of Hubei Province, Hubei Province Scientific and Technological Research Project, Jingzhou Science and Technology Development Planning Project, Guangzhou Key Medical Discipline Construction Project, National innovation and entrepreneurship training program for College Students, Hubei Province Health and Family Planning Scientific Research Project, Hubei Province Natural Science Foundation of China. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Core tip" section. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
