raised by the reviewers should be answered; and (3) Format: There is 7 figures. A total of 128 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) I found no "Author List" section. Please provide the author list; (2) I found no "Author Institutions" section. Please provide the author institutions; (3) I found no "Author contribution" section. Please provide the author contributions; (4) I found no "Corresponding author" section. Please provide the corresponding author; (5) I found no "Abstract" section. Please provide the abstract; (6) I found no "Key words" section. Please provide the key words; (7) I found no "Core tip" section. Please provide the core tip; (8) I found the authors did not provide the original figures. Please provide the original figure documents.
