The topic is within the scope of the WJC. (1) Classification: Grade C (The first reviewer didn't find the manuscript, and his/her comments are ineffective); (2) Summary of the Peer-Review Report: In this manuscript, authors reported a rare case of a 33-year-old postpartum female who presented with</p>	[Y]

sudden onset chest pain and was diagnosed with SCAD and given urgent catheterization. The author also highlighted possible benefits of PCI and CABG for such high-risk patients. The overall rationale of the manuscript is interesting. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 28 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors are native English speakers. 3 Academic norms and rules: The written informed consent of treatment is not provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for
