a great deal of polishing. The questions raised by the reviewers should be answered; and (3) Format: There are 8 figures and 1 table. A total of 77 references are cited, including 11 references published in the last 3 years. There are 7 self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors are required to provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. The authors have published preprint (<https://www.researchsquare.com/article/rs-67533/v1>). 4

Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJV. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The author should number the references in Arabic numerals
