to cardiovascular disease. Overall, it is well-written and deserves significance. However, there are some issues should be addressed. There are some spelling mistakes and format errors. The authors need to add the novelty of this review. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 220 references are cited, including 141 references published in the 2020. There are 8 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Magnum Proofreading was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6
