The topic is not within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is a well written review. Adding a few lines regarding peroxisome proliferator-activated receptors and their novel ligands as potential therapeutic targets, as well as improving the quality of the figures would make this review a better work. answered; and (3) Format: There are 7 figures and 1 table. A total of 49 references are cited, including 13 references published in the last 3 years. There are 13 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by FirstEditing was provided. 3 Academic norms and rules: The authors are required to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The highest single-source similarity index in the CrossCheck report showed to be 6%. According to our policy, the single-source similarity should be less than 5%. Please rephrase these repeated sentences. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Agencia Nacional de Promoción Científica y Tecnológica, FONCyT, and CONICET Proyectos Unidades Ejecutoras 2017. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The author should number the references in Arabic numerals according to the citation order in the text.
