The topic is within the scope of the WJR. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Typical features of COVID-19 and H1N1 pneumonia are by now well described and the paper adds little to current knowledge. Nevertheless the authors have listed in great detail the predominant imaging features and how</p>	[Y]

they may be different which may be useful for some; and (3) Format: There are 2 tables and 6 figures. A total of 102 references are cited, including 77 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJR. 5 Issues raised: (1) The short title should be added; (2) The author's information should be added in the first page; (3) The "Author Contributions" section is missing. Please provide the author contributions; and (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
