The questions raised by the reviewers should be answered. (3) Format: 5 tables and 2 figures. 24 references were cited, including 16 references published in the last 3 years. No self-citation. 2 Language evaluation: B. Language editing certificate was provided. 3 Academic norms and rules: The authors provided the biostatistics review certificate, the institutional review board approval form, the conflict-of-interest disclosure form and Clinical Trial Registration Statement. The authors need to provide signed the copyright license agreement. The CONSORT 2010 declaration does not meet the requirements. Download the CONSORT 2010 declaration file and add page numbers. No academic misconduct was found in the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) The topic has not been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Recommendation: Conditional acceptance.
