is within the scope of the WJT. (1) Classification: Grade C, Grade C and Grade C; (2) Summary of the Peer-Review Report: The study is interesting, and the authors evaluated many parameters using proper statistical tests. Also, the manuscript is well-written, and the discussion of the results rational and balanced. However, there are some issues should be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables. A total of 47 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. The authors need to provide the informed consent, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJT. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (3) the author should number the references in Arabic numerals according to the citation order in the text. The reference

	<p>numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (4) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as $aP < 0.05$, $bP < 0.01$ ($P > 0.05$ usually does not need to be denoted).
