2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of Huanglian Decoction suppresses the growth of hepatocellular carcinoma cells by reducing CCNB1 expression. The topic is within the scope of the WJG. (1) Classification: B, C, and D. (2) Summary of the peer-review report: The authors utilized several databases to find the main DEGs in HCC and Huanglian Decoction inhibits the growth, migration and invasion via CCNB1. Major: Authors should discuss how the compounds in Huanglian</p>	[Y]

Decoction could activate what signal pathways to inhibit cancer cell apoptosis, cell cycle, cell migration and invasion, and describe multi-compounds, multi-targets and multi-effects feature of Huanglian Decoction in HCC treatments. In the section 3.7, only 3 groups in the experiments shown in Figure C/D/E/F were insufficient, the effect of Huanglian Decoction on CCNB1 cannot be demonstrated clearly. The questions raised by the reviewers should be answered. (3) Format: 1 table and 7 figures. 42 references were cited, including 16 references published in the last 3 years. No self-citation. 2 Language evaluation: Grade A, B, and B. 3 Academic norms and rules: The authors provided the biostatistics review certificate. This study did not conduct animal or human experiments. The authors are required to sign the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The "Article Highlights" section is missing. Please

add the “Article Highlights” section at the end of the main text;
and (4) Please don’t include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01. 6 Recommendation: Conditional acceptance.
